CREDIT TERMS AND SALES AGREEMENT

- 1. Applicant hereby authorizes release of information from the bank and credit references disclosed on this Credit Application, as well as credit bureau and/or credit reporting agencies and grant the right to obtain from such entities information Haycock Petroleum Company deems necessary to enable it to evaluate this Credit Application. In addition, Applicant hereby authorizes the references disclosed herein to release to Haycock Petroleum Company all information requested by Haycock Petroleum Company pertaining to Applicant's accounts, business practices and credit history. If required, Applicant agrees to give written authorization to such entities to furnish information to Haycock Petroleum Company.
2. Oils, lubes, grease and specialty products are due NET 30 DAYS and fuel NET 10 DAYS following the date of delivery. The invoice price shall carry a late charge of 1 1/2% per month. In the event of a returned check, a \$50.00 handling charge per check may be immediately levied against Applicant.
3. If Applicant applies for issuance of a Cardlock access card(s) from Haycock Petroleum Company.

The Applicant shall be entitled to all the privileges of a Cardholder which include: providing electronic purchase and credit authorization, transaction processing, and management reporting services, to its Cardholders. Applicant may also purchase fuel and other goods or services, as authorized by Haycock Petroleum Company, at its participating service centers. Applicant agrees to accept responsibility for distribution of Personal Identification Numbers (PIN) as well as safety instructions and operating instructions to each driver authorized to make purchases on the Applicants account the organization will be liable to Haycock Petroleum Company for all amounts and for all liability occasioned by the unauthorized use of such card. That upon receipt of Cardlock access card or approval of use of card(s) other than the Cardlock access card, the electronic interface of card number and Personal Identification Number (PIN) that verifies cardholder's account of persons designated to purchase on cardholder's account, shall serve as a signature. Applicant provides Haycock Petroleum Company, the credit information attached hereto. If Haycock Petroleum Company establishes a Cardholder account for its use of cards, Applicant will be billed on the twenty-fifth (25th) of each month, and agrees to pay upon receipt of statement prior to the 10th of the following month. If the Cardlock access card is used at an ARCO Pay Point Network, the Applicant agrees to pay a transaction fee of 6%, which will be added to the monthly fuel report billing.

- 4. In the event it becomes necessary for Haycock Petroleum Company to employ counsel to enforce any of the provisions of this Agreement, Applicant shall pay to Haycock Petroleum Company all costs incurred in such enforcement including, without limitation, reasonable costs and attorney's fees.
5. This Agreement shall be construed under the laws of Nevada and Applicant hereby consents to said jurisdiction and venue for any dispute resolution.

Personal Guaranty

The undersigned hereby unconditionally and absolutely guarantees to and for HAYCOCK PETROLEUM COMPANY the due performance, including, without limitation, the prompt payment when due, whether at stated maturity, by acceleration or otherwise and at all times thereafter, of any and all obligations of Applicant now or hereafter owed to HAYCOCK PETROLEUM COMPANY under any contract or agreement now or hereafter entered into between HAYCOCK PETROLEUM COMPANY and Applicant (the "Obligation"). In addition to the above Obligation, the undersigned unconditionally guarantees the immediate payment of the assignment for the benefit of creditors by, or commencement of any bankruptcy, reorganization, arrangement, moratorium or other debtor relief proceedings by or against the Applicant or the undersigned, or (b) upon the appointment of a receiver for, or the attachment, restraint of, or making or levying of any order of court or legal process affecting the property of the Applicant or the undersigned. In addition to the amount guaranteed hereunder, the undersigned agrees to pay attorney's fees and all other costs and expenses incurred by HAYCOCK PETROLEUM COMPANY in enforcing this Personal Guaranty. This Personal Guaranty and the liability and obligations of the undersigned and the undersigned's heirs, executors, administrators, successors and assigns, and all references herein to HAYCOCK PETROLEUM COMPANY shall include its successors, transferees and assigns.

The undersigned waives any right to require HAYCOCK PETROLEUM COMPANY; (A) to proceed against the Applicant, (B) to proceed against or exhaust any security received for the Applicant, or (C) to pursue any other remedy in HAYCOCK PETROLEUM COMPANY'S power whatsoever. The undersigned waives all presentments, demands for performance, protests, and notices, including, without limitation, notices of non-performance, notices of protest, notices of acceptance of this Personal Guaranty and notices of the existence, creation, or incurring of new or additional Obligations. The undersigned understands and acknowledges that this Personal Guaranty will be relied upon by HAYCOCK PETROLEUM COMPANY for each and every instance HAYCOCK PETROLEUM COMPANY extends credit to applicant, and that HAYCOCK PETROLEUM COMPANY would not extend credit to Applicant in the absence of this Personal Guaranty. As such, this Personal Guaranty shall continue, survive, and remain in effect until HAYCOCK PETROLEUM COMPANY receives written notification by certified or registered mail of it's withdrawal.
